SAFETY WARNINGS FOR USE IN-EAR HEADPHONES

The following list of safety warnings has been compiled in accordance with the requirements of the General Product Safety Regulation (EU) 2023/988 (GPSR). Its purpose is to protect users from potential hazards arising from the misuse of products. The warnings have been formulated in a simple and understandable way to be accessible to a wide audience, including the elderly and people with reduced mobility.

The in-ear headphones offered by manufacturer NTEC sp. z o.o. are CE certified, which proves their compliance with EU safety standards.

Use the in-ear headphones as intended and as recommended by the manufacturer.

BASIC HAZARDS AND PRECAUTIONS

1. Risk of electric shock:
 - Do not use the headphones when connected to power in high humidity conditions (e.g. in the rain).
 - Ensure that the power cable and connectors are not damaged before each use.
2. Risk of overheating:
 - Do not leave the headphones in direct sunlight or near heat sources to avoid overheating the device.
 - Store the headphones in a dry and cool place when not in use.
3. Sound hazards:
 - Do not use the maximum volume for long periods of time to avoid permanent hearing damage.
 - Use the volume restriction function if available, and take regular breaks while listening.

SPECIFIC HAZARDS ARISING FROM USE

4. Risk of injury or abrasion:
 - Do not use headphones with damaged ear cushions or protruding parts.
 - Regularly check the physical condition of the headphones and replace damaged components.
5. Safety in wet conditions:
 - Do not immerse the headphones in water or use them in extremely humid environments unless they are waterproof.
 - Make sure your hands are dry before handling them.
6. Hazards associated with mobile use:
 - Do not use headphones in situations where full attention is required (e.g. when driving).
7. Fire hazards:
 - Avoid charging headphones unattended and near flammable materials.
 - Use only original chargers and cables compatible with your device.
8. Cybersecurity:
 - Connecting headphones to untrusted devices can put you at risk of data interception or infecting your device.
 - Use only trusted devices

MAINTENANCE PRECAUTIONS

9.  Cleaning the device:

- Do not use aggressive cleaning agents that may damage the surface of the headphones or their electronic components.
 - Clean the headphones with a soft, slightly damp cloth and make sure they are completely dry before use.
- 10. 🛠 Maintenance of the mechanism:**
- Neglecting maintenance can shorten the life of the headphones and increase the risk of damage.
 - Regularly check the physical condition of your headphones, including cords and tips, and keep them clean.
- 11. 📦 Storage:**
- Store the handset in a dry, clean place, away from moisture, dust and sources of heat, to ensure it lasts as long as possible without failing.

ADDITIONAL WARNINGS

- 12. Child safety:**
- The small parts of the headphones can be a choking hazard for small children.
 - Keep headphones out of reach of children under 3 years of age.
- 13. Avoid modifications:**
- Do not attempt to repair or modify the card reader yourself, as this may affect its safety and quality of operation.
- 14. Action in the event of an emergency:**
- If the unit exhibits abnormal operation, such as overheating, sparking, unusual odour or noises, immediately switch it off and disconnect it from the power supply and then contact the service centre.
 - If you observe any unsafe product behaviour, contact the manufacturer urgently.
